#### **PREFACE**

- With the changing scenario of socio economic development of the society, the use of drugs and alcohol is also increasing exponentially amongst all the sectors of the society particularly amongst the youngsters and student community.
- Resultantly there is a tremendous increase in the violent activities heinous crime, unrest, gang wars and above all huge stress on the general health system, which may include deterioration in the mental, physical and psychological health ranging from moderate to severe. In extreme cases, it becomes fatal.
- The Management of Dolphin (PG) Institute in its endeavour to ensure good health and over all development of the students intends to keep its campus and hostels free from abuse of drugs and has come forward with the annexed Anti Drug/ Liquor Policy.
- The Management has advised that the students of Dolphin (PG) Institute, a premiere institute, that they should not indulge themselves in the use of drugs, rather the Management solicit the support and assistance from the students in the implementation of the said Policy in letter and spirit to the functionaries of the institute to keep the campus and the hostels free from drug abuse and to ensure all round development of the students in line with the Vision and Mission of the Institute.

#### ANTI NARCOTICS POLICY

1. Dolphin (PG) Institute is committed to maintain a conducive teaching learning process in order not only to achieve academic and vocational excellence but also to ensure physical, intellect and emotional growth and development of the students as the students are the future of nation building. The Institute is a staunch believer that the use of narcotics (drugs, alcohol and contrabands and prohibited medicines) shall impede with student's educational goals and shall also obstruct the process of teaching and learning environment in the campus.

The Institute in its endeavor to have a conducive environment has a stringent policy applicable to all the students on narcotics menace, the features of which are as below for guidance and implementation. It is also expected from all the students, faculty and other staff members of the institute for full support and cooperation in the implementation of the policy.

## **Features of the Policy:**

- 2. To keep constant vigil on the use of narcotics in the premises of the campus and residential hostels, the "Anti Narcotic Cell" is in place to ensure conducive environment.
- 3. DSWC shall organize seminars and talks by the eminent personalities on abuse of narcotics to educate the students to spread awareness amongst one and all.
- 4. To keep a close watches on the suspects so that the remedial measures are taken at the initial stage to avoid major threats.
- 5. The departments should issue advisories periodically to the students so that they do not indulge themselves in the use of narcotics. Rather, the students should assist the management and its functionary to implement the policy meticulously to ensure narcotic free campus and suitable environment for the studies, co-curricular and extracurricular activities.
- 6. Students as per this policy are required to adhere strictly to the specific norms as stated below. This policy is a part and parcel of the rules and regulations of the Institute.
- 7. The purchase, possession, use, consumption, sale, distribution or storage of cigarettes, any alcoholic beverage, contraband substance or contraband drug is prohibited on or off campus. This prohibition extends for the student until he is a bonafide student of this Institute. This is applicable to a student found actively or passively, or being part of a conspiracy to promote such activities amongst other students.
- 8. If any student is found under the influence/possession/distribution of alcohol/drugs or in possession of banned drugs/substances or if found distributing the same or is caught smoking cigarettes/ chewing of tobacco in the campus or outside, as long as he/she is a student of Dolphin (PG) Institute, the matter will be immediately referred to the Anti Drug Cell of the Institute, whose findings will be binding and irrevocable and Disciplinary Action Committee shall take suitable action against the erring student including rustication of such student from the rolls of the Institute. An undertaking to this effect shall be submitted by the students and their parents at the time of admission. Undertaking (Annexure 1 & 2) shall be provided by all existing and newly admitted students and their parents.

- 9. Under suspicious circumstances, the students may be asked to undergo Breath Test for use of contraband items at any point of time in/ outside the campus of the Institute.
- 10. Students involved in road accidents/ negligent driving shall also be asked to submit the Breath Test report.
